Only currently nationally certified E Level coaches and above will be allowed on the competition floor and to sit in the designated chairs. In order to expedite the registration process, the completed Coaching Application Form (below) must be received by Thursday, November 18, 2010. Applications received after November 18, 2010 will be charged a \$10.00 processing fee. Coaches who register as “walk-ups” will be charged a \$20.00 fee. A coaching pass can be applied for every 5 players entered with a maximum of 5 per club. Coaches are expected to set an example for their players by conducting themselves in a respectful and professional manner.

Coaches must prominently display their official issue unexpired coaching photo identification badge at all times during the tournament.

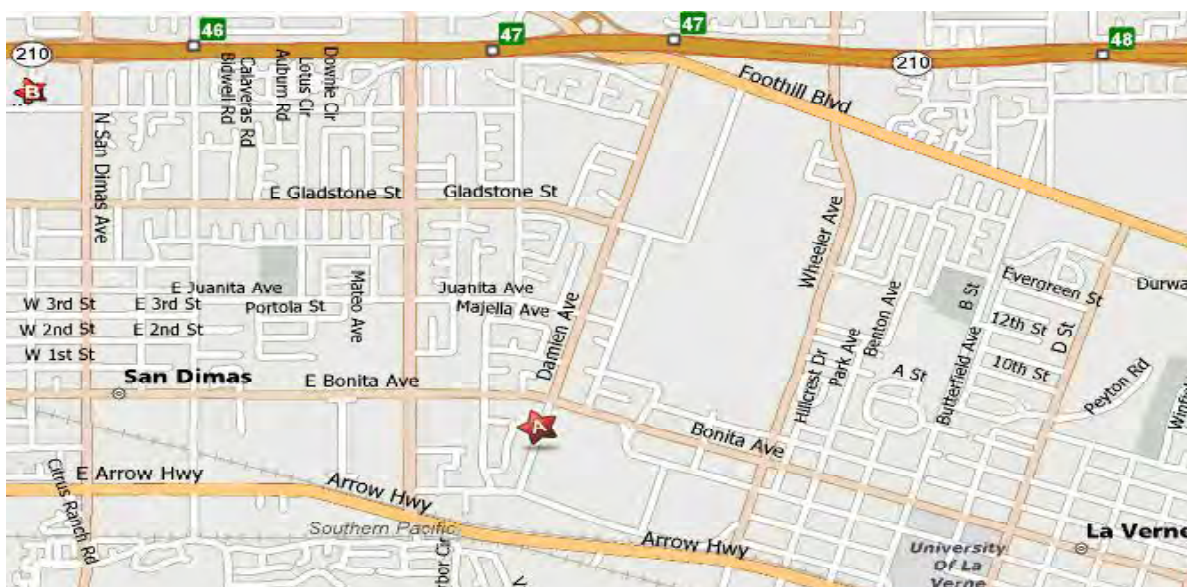
